BOARD OF DIRECTORS MEETING MINUTES

April 15, 2020

Location: Call in Meeting

Call to Order – Mike Lee, President at 2:00 p.m.

- Introductions, Announcements, Agenda Item Changes, Public Comment:

- Business Items: Special Board Meeting to discuss the state of MCWRA and the recruitment of a new Executive Director

The Board met to determine next steps in the recruitment process for an Executive Director and requested the Recruitment Ad/Hoc Committee consider any additional options moving forward.

Staff presented a list of candidates that expressed interest in the Executive Director and/or Support Services role.

Joint Role; Executive Director and Support Services

- Bob Reeb and Rick Lind also submitted a joint proposal in additional to stand-alone interest
- Rob Roscoe has indicated that Interwest could fulfill the role of Executive Director and Support Services

The Board discussed several scenarios with focus on the changed conditions due to COVID-19. What would conditions look like post COVID-19 and what should MCWRA do in the meantime, let alone planning the direction of MCWRA for the next 5-10 years.

Board members raised individual alarms that resonated during the meeting. For example:

- □ The downturn in the economy could result in less membership dues
- □ Revenue impacts to the budget and to the reserve designation
- □ Tours and programs cancelled in the short-term and likely will be altered on-going
- California-United Water programs cancelled for the year; MCWRA, UWI, Mesa Water, BAWSCA
- □ Building new statewide relationships behind a camera, may be a challenge

The Board discussed hiring a new executive director, EN2 for the support services, advertising for more candidates, and staying in a holding pattern and the consensus was to stay as a "caretaker" for the association. The Board also authorized the executive director to contract with EN2 for support services and for the Recruitment Ad/Hoc committee to consider options for moving forward.
