1. Consideration to approve the June 24, 2022 Board Minutes

2. California-United Water Conference and Caldor Fire Tour Financial Debrief

Justin Caporusso provided a financial debrief of the California-United Water Conference and Caldor Fire Tour, outlining the expenses and revenue, and specific line items of interest.

3. Review of MCWRA Financial Information: Proposed Retained Earning Policy – ACTION ITEM

Following discussions during the June 24, 2022 Board of Directors meeting, staff explored a number of options for a recurring, sustainable contribution to the Retained Earnings line item in the Budget that would (1) fit within the existing operations of the association, (2) incentivize membership growth, and (3) not impact outreach and education activities. Justin Caporusso presented a proposed policy that would dedicate 2.5 percent of total annual membership revenue to Retained Earnings, effective the 2022-2023 Budget year.

- 4. Review of MCWRA Financial Information: Updated 2022/2023 Budget ACTION ITEM

The Board of Directors preliminarily approved the 2022-2023 Budget pending final clearance of June 2022 expenditures and future discussions on transferring funds to the Retained Earnings account during the June 24, 2022 Board meeting. Justin Caporusso provided an overview of the updated Budget, noting that outstanding expenses have since been paid, and a payment for membership dues was received and cleared before the close of the 2021-2022 fiscal year. The remaining revenue/income from 2021-2022 equaled \$23,153.61, which as discussed will be carried over as part of the "Lobbyist/Advocacy" line item in the 2022-2023 proposed Budget (shown as "Revenue Unappropriated prior to Jul 1, 2022"). This line item has since been updated to "Lobbyist/Advocacy/Strategic Planning."

Additionally, Caporusso explained that the 2022-2023 proposed Budget had been developed assuming the existing revenue from membership remains the same for the coming year. A loss in membership would result in a loss of revenue, and vice-versa.

Following approval of the Retained Earnings Policy, Caporusso suggested that the Board consider an escalator for membership dues at an upcoming meeting.
